Bridging the Gap: A Tale of Gratitude Amidst Newcomers' Challenges

At this time of the year, when many Canadians gather with their families, friends, and relatives to revel in the holiday spirit, it is essential to acknowledge the contrasting reality faced by a significant number of newcomers. For those who have fled their home countries due to war, conflicts, and the risk of persecution, the joy of festive gatherings remains elusive.

Amena, a newly elected board member, provides a poignant illustration of the challenges faced by newcomers during the holiday season. Having been separated from her family for numerous years due to her refugee status, Amena recently seized the opportunity to reunite with her mother and some family members in Iran. The emotional reunion marked the end of a prolonged separation that had prevented Amena from participating in significant family celebrations, including her younger sister's wedding, the birthdays of her nephews and nieces, and even the funeral of her older sister.

Amena's journey to Iran exposed her to the harsh realities experienced by her Afghan compatriots—challenges ranging from physical abuse and detention to forced payments, accommodation in camps, slave labor, and the heart-wrenching separation from their families. While Amena expresses gratitude for the safety and security she now enjoys in Canada, like many other newcomers, her concerns and worries linger for the family and loved ones left behind.

As we celebrate the joys of the holiday season, let us not forget those who are navigating the challenges of displacement. Amena's story serves as a poignant reminder of the importance of empathy, support, and the positive impact each one of us can make in the lives of newcomers seeking refuge and a sense of belonging in our welcoming Canadian communities.

Rent Subsidies of \$140,000 to 30 Newcomer Families & Individuals

was a great year for OMRA. With your financial support, we were able to provide rent subsidies of over \$150,000.00 to thirty newcomers. And all this is done solely by volunteers!

OMRA celebrated together, expanded our efforts to provide tutoring and mentoring for each of our families and had a record-breaking year for grocery card sales. We continued to provide start up kits and to support affordable housing in Ottawa through our membership in the Alliance to End Homelessness.

A heartfelt thanks to our dedicated members, volunteers, funders and everyone involved. Your support is the driving force behind our mission, thank you for making a difference and we are grateful for all you do and give.

The OMRA Grocery Card Fundraiser shattered records in December, selling over \$80,000.00 worth of cards.

OMRA's Grocery Card Fundraiser has over 220 individual participants and is still growing! Thank you to all who make this program work. It provides OMRA with **\$50,000/year**, all of which fund our rent subsidies for newcomers.

How did Kindred Credit Union help OMRA to Welcome Refugee Families?

In 2023, Kindred Credit Union awarded a \$5,000 grant for a pilot project to help OMRA set up the first apartment for newcomer families. We used these funds to pay furnituremoving expenses, buy mattress covers and six Chromebooks to help with schooling, plus we bought fans during the hot summer.

For every newly arrived family, OMRA provides a set-up kit consisting of small donated items that every family needs, usually consisting of lamps, all the essential items for a kitchen, and bedding. This project has allowed OMRA volunteers to interact personally with each family on the very important day when move their thev from temporary accommodations in a shelter to their first home in Canada. This program complements and puts a human face to the financial monthly subsidy that is the essence of our charity.

This pilot project has inspired us and made us realize that volunteer Canadians can have an enormous impact on newcomer families, in a way that a paid over-worked case worker never can. One client told us that the day she received a start-up kit from an OMRA volunteer she finally felt welcome in Canada. It demonstrated in a tangible way there there are Canadians who care about them, in a time when most feel so alone.

Organizations	Amount	Purpose
alterna <mark>savıngs</mark>	\$1,000	Purchase educational materials to provide OMRA volunteer tutors with the required resources
CATHERINE DONNELLY FOUNDATION	\$50,000	Evaluation study of the effectiveness of OMRA's portable rent subsidy program. Study is being conducted by Professors Aubry and Roebuck at the University of Ottawa.
